We believe that the blockchain is a public ledger, and those in positions of power must do more to empower people and uphold the core principles of this technology.

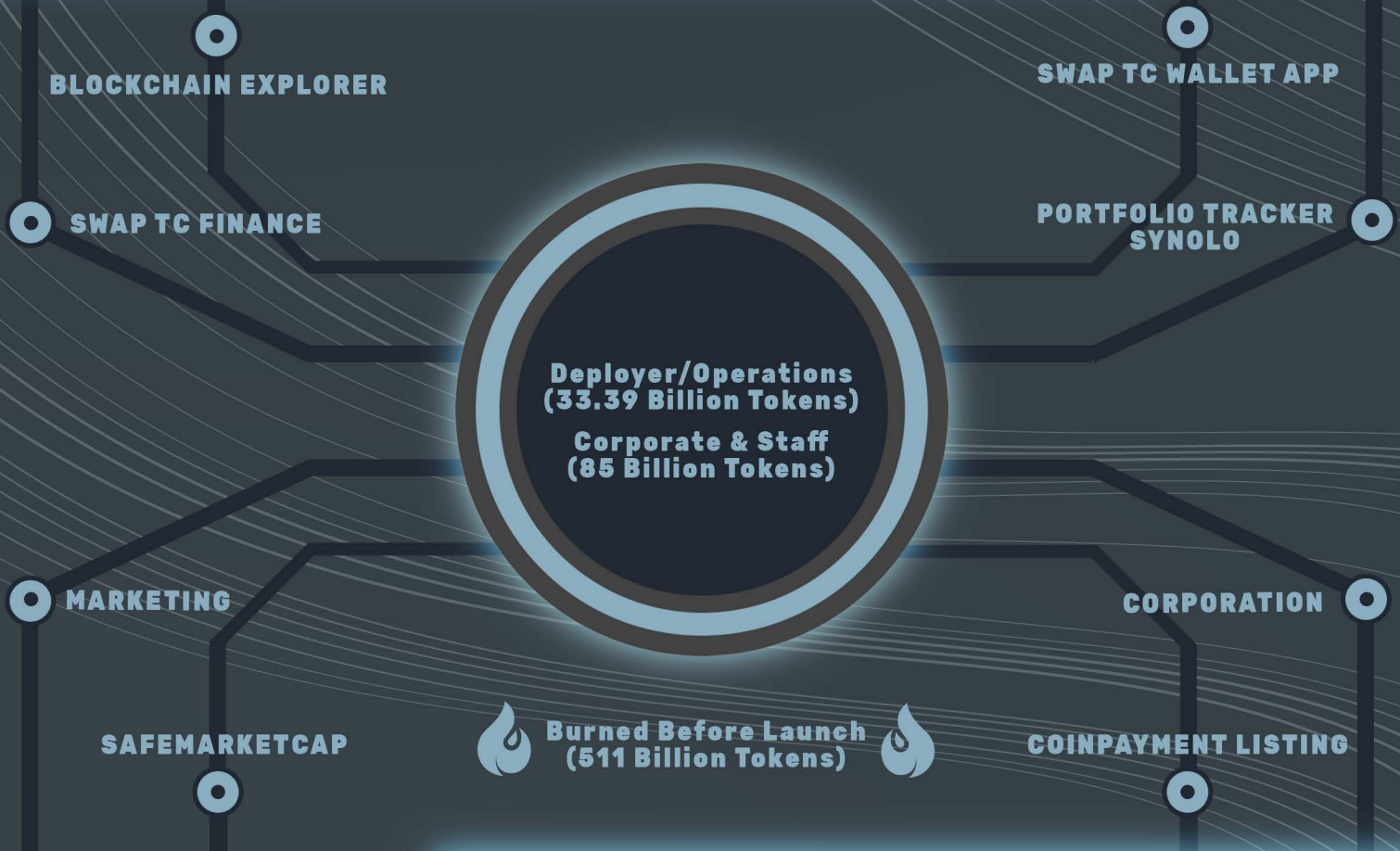

## Breakdown - Tokenomics & Reflections

Swap TC is the first crypto token to implement a tax system that rewards long-term holders on an individual basis. When you purchase \$SWAPTC, there is a 5% purchase fee. Sell and transfer fees start at 20% and then gradually decrease by 0.5% every week for 19 weeks. If you transfer \$SWAPTC to another wallet, the tax system will reset back to week zero for the receiving wallet.

In order to receive BNB (BEP20) reflections, you must hold at least 250 million \$SWAPTC. The amount and frequency of your BNB reflections will depend on the volume and amount of \$SWAPTC you hold. We recommend using our web-based reflections tracker, available on our website, to track your tax rate and redistribution.

## Corp, Staff Dividends & Deployer

The corporate wallet for Swap TC is divided into different liquidity pools to fund the development of the platform. In order to align the interests of the staff members with the success of the company, a commission-based salary system is implemented through a dividends contract. This contract allows the staff to receive reflections, but keeps the tokens locked for security reasons. Only the core team has access to the contract to add and remove staff members. If a staff member decides to leave Swap TC, the corporation will request to buy back the tokens to prevent a negative price impact.

The deployer wallet is exempt from fees and dividends, and will be used for future exchanges. To ensure the security and integrity of the platform, the core staff members who have access to important wallets have undergone Bronze Tier KYC verification by Reflex Finance, and a comprehensive KYC verification with AnonyDoxx for the entire team.

The tax system that has been implemented was influenced by a concept in physics known as the Center of Mass Formula. This formula states that the product of the total mass of a system and the position vector of the center of mass is equal to the sum of the products of the masses of the individual particles in the system and their respective position vectors. Essentially, the center of mass of a system is determined by the distribution of mass within that system.

## DISCLAIMER

Slippage, or the difference between the expected price of a trade and the actual price at which the trade is executed, can be quite high for those trying to sell during a high tax week. This is because slippage is affected by various factors, including liquidity, price impact, and the amount of tax being charged. In general, slippage will be higher when liquidity is low, price impact is high, and tax fees are high.

During a high tax week, slippage is typically between 12% and 40%. However, it is important to note that this range is just an estimate, and actual slippage may vary depending on market conditions. Over time, slippage is expected to gradually decrease as liquidity increases and tax fees decrease. For example, the estimated slippage for Week 19 is 12% to 18%. Buy slippage is also estimated to be around 12%.

It is important for traders to be aware of slippage and to take it into account when planning their trades. By understanding how slippage is affected by different factors, traders can make informed decisions about when and how to execute their trades in order to minimize slippage and maximize the efficiency of their trading strategy.

**Q** What is the total supply?

**A** 1 Trillion (1,000,000,000,000)

**Q** How many developer wallets are there?

**Q** What is the initial price/rate?

**A** 1 BNB / 500,000,000 SWAPTC (0.5B)

**Q** What are the tokenomics?

**A** Buy: 5% (Slippage 10-12%)  
Sell/Transfer: (20%/10.5%|Week 0/19)  
Slippage (40%-12%)

**Q** What happens if I transfer tokens to another wallet after the initial purchase?

**A** If you transfer tokens to a different wallet the tax rate will reset back to week zero because the smart contract won't recognize the new wallet's time-stamp.

**Q** If I buy at launch, I know that if I sell whenever, my 19th-week tax rate resets, but say I get down to the 10th week and I buy more. Will my 19th-week wait time start over to zero week?

**A** If you transfer your tokens to a new wallet, only the receiver (i.e., the new wallet) will experience a reset in the timeline for the vesting of their tokens. It is important to note that this reset will not be a complete reset to week zero, but rather will be an averaging of the timing between the receiver's first purchase and the most recent purchase.

**A** 250 Million to receive BNB (BEP20)

**A** Presale: Aug 12th, 2022 on the Reflex Finance Launchpad. Swap TC is tradable on Pancake - Swap and Reflex Swap as of August 20th, 2022.

**Q** Did you complete an audit?

**A** We've completed our smart contract's audit with InterFI. It is available on our website (swaptc.com).

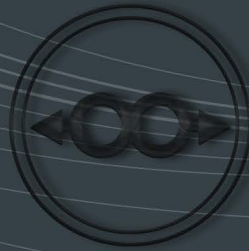
